## Minutes of the Harbour Island Villas Condominium Association Annual General Meeting ("AGM")

- 2. The Chairman moves to appoint Mr. Silvano Gai to act as Secretary for the meeting and would be taking the minutes thereof. Hector Sosa seconds. The motion carries unanimously.

4. The Chairman introduces the Directors from the prior board and communicates that Mr. Silvano Gai and Mr. Hector Sosa do not intend to be re-elected. The Chairman asks for volunteers to serve in the Board of Director of the Harbour Island Villas Condominium Association.

5. 2017 - 2018 Budget. Dean present the budget approved for the next fiscal year on October 25<sup>th</sup>. Dean proposes that the AGM confirm the budget approved by the Board. A motion is made by Alana Markus and seconded by Hector Sosa to approve the budget. The motion carries unanimously.

## 6. Updates from Dean

- a. Revenues are down due to hurricane. Even if the hurricane didn't hit Valentines, many potential customers especially in the Florida area were damaged by the hurricane. Potential customers assume that Bahamas are the same as Caribbean. This is impacting revenues.
- b. Valentines did lot of dedicated advertisement to boater to reroute yachts from the damage Caribbean Island to Harbour Island.
- c. By the end of the year the conference facility will open.
- d. Hospitality courses continue to be offered to all personal.
- e. From Marketing point of view Valentines will follow "the retargeting approach", Valentines has a 30,000 email-database.
- f. Groups are the next target. Valentines has, for example, a wedding guide for wedding parties.
- 7. Long term contingency goal. The board decided to collect a Reserve Contingency of 60,000 USD per year. In addition, only for the unit having a kitchen, there will be a special assessment to replace the appliances.
- 8. Capital improvements and/or maintenance items for the next five years, both for the condominium association and for individual owners. The big items are:
  - a. Appliance replacement
  - b. Windows treatment
